Themes:

Positive – Topics for positive media coverage include the new SARC centre, outcome of the CQC unannounced visit and subsequent report, and recognition of work undertaken by volunteers.

Negative- All bar one of the negative coverage related to the case of a baby who died shortly after birth. The George Eliot Hospital NHS Trust expressed its sincere condolences and offered profound apologies for the failings in the care provided. Several lessons have been learned as a result of this case and changes implemented to improve processes as a result. The high number is as a result of coverage in local media across the country.

#### 4. POLITICS SHOW

The Chief Executive appeared on the Politics show (Sunday 17 February) to respond to, and debate issues in relation to, the independent review of mortality rates and issues in relation to the publication of the report of the Mid Staffordshire NHS Foundation Trust Public Inquiry.

#### 5. OASIS PROJECT GRADUATION CEREMONY

A Graduation Ceremony took place in February to congratulate the team of volunteers who have achieved a professional relaxation qualification through the George Eliot Hospital Trust's Oasis Project. The Oasis Project aims to create a calm, tranquil environment in which patients can relax and de-stress ahead of a medical or surgical procedure, away from the clinical setting. Currently this setting is the hospital Chaplaincy Centre but as the Project grows it's hoped that it can be implemented throughout the hospital and in the wider community.

Patients are taught strategies and techniques including relaxation, breathing and visualisation and an offer of an aromatherapy hand massage; these are all given by the volunteers who are trained in these techniques through the School of Natural Health Sciences. The Trust is proud to say that all of its volunteers achieved an A grade in their Diploma assessments which is an excellent achievement.

#### 6. LORENZO

The George Eliot is one of four Trusts currently working with Connecting for Health and CSC to implement a new suite of clinical IT systems. This is extremely good news for the Trust as it will enable us to upgrade most of our clinical systems and provide external financial support to allow us to do so, for the benefit of patient care.
