



Q6 How is being a member of the CCG impacting on your clinical work as a GP?







Q11 Has your CCG invited you to propose plans to use this resource?



Q12 If you were offered this additional £5 per patient funding, what plans would you propose to the CCG? (tick all that apply)



Q13 How successful has your CCG been in moving resources to match the transfer of services from secondary to primary care?



Q14 Compared to previous PCT arrangements, do you now feel you have:




